**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Termination") is executed and delivered as of the 22nd day of June, 2015 by MCG Capital Corporation (the "Secured Party"), to Integratechs Inc, a Utah corporation (the "Company").

**BACKGROUND**

A. The Company executed and delivered to the Secured Party a joinder to the Security Agreement dated as of September 26, 2012 (the "Security Agreement"). Capitalized terms used but not defined herein are defined as set forth in the Security Agreement.

B. Pursuant to the Security Agreement, the Company granted to the Secured Party a security interest in the trademarks set forth on Exhibit A attached hereto and made a part hereof.

C. The Notice of Grant of Security Interest in Trademarks was recorded in the United States Patent and Trademark Office ("USPTO") on May 1, 2013 at Reel/Frame 5019/0349

NOW THEREFORE, with the foregoing Background incorporated by reference and intending to be legally bound hereby, the parties agree as follows:

1. The Secured Party terminates and releases all of its rights, title and interest in the trademarks set forth on Exhibit A.
2. At Company's expense, the Company, or its designee, may record this Termination in the USPTO and in any other trademark offices as may necessary to carry out the intentions of this Termination.
3. At Company's expense, the Secured Party agrees to execute and deliver such other documents as may be reasonably requested and prepared by the Company, or its designee, to carry out the intentions of this Termination.
