SECOND SUPPLEMENT TO TRADEMARK SECURITY AGREEMENT

This Second Supplement to Trademark Security Agreement (this “**Supplement**”) is made as of the 23rd of June, 2015 by **CROSS MATCH, INC.**, a Delaware corporation (“**Holdings**”), **CROSS MATCH HOLDINGS, INC.**, a Delaware corporation (“**Parent**”), **CROSS MATCH TECHNOLOGIES, INC.**, a Delaware corporation (“**Borrower**”), and **CROSS MATCH TECHNOLOGIES GMBH**, a German limited liability company (*Gesellschaft mit beschränkter Haftung*) (“**German Subsidiary**”; and together with Holdings, Parent, and Borrower are, individually, each a “**Grantor**”, and collectively, the “**Grantors**”), in favor of Silicon Valley Bank, as Administrative Agent (in such capacity, together with its successors and permitted assigns, (“**Administrative Agent**”)) for the Secured Parties.

WHEREAS, the Grantors executed and delivered a Trademark Security Agreement dated July 13, 2012 and recorded on July 13, 2012 at Reel 4820, Frame 0740, as supplemented by First Supplement to Trademark Security Agreement dated April 17, 2014 and recorded on April 18, 2014 at Reel 5263, Frame 0813 (as amended and of record from time to time hereinafter, the “**Grant**”) in favor of the Administrative Agent, pursuant to which the Grantor pledged, assigned and granted a security interest in certain Trademarks (as defined therein).

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:

1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Grant.
2. Supplement to Schedule A. Schedule A to the Grant is hereby supplemented, but not replaced, by Schedule A-2 annexed hereto.
3. Miscellaneous:
 - a. Except as provided herein, all terms and conditions of the Grant remain in full force and effect.
 - b. This Supplement covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.
