2. hereby assigns to Debtor, without recourse or representation or warranty of any kind, any and all rights, title or interest Secured Party may have obtained pursuant to the Trademark Security Agreement in or to the Trademarks of Debtor; and
3. authorizes and requests that the USPTO note and record the existence of the release hereby given.
