TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of June 25, 2015 by Sun Pace American Finance, LLC ("Sun Pace").

WITNESSETH:

WHEREAS, Sun Pace and PACE AMERICAN ENTERPRISES, INC., a Delaware corporation ("Grantor"), were parties to that certain Short Form Trademark Security Agreement dated as of June 25, 2010 (the "Security Agreement"), pursuant to which Grantor granted a security interest to Sun Pace in certain trademarks and trademark licenses (the "Secured Trademarks") as security for certain obligations owing by Grantor to Sun Pace, including the Secured Trademark set forth on Schedule A hereto; and

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on July 2, 2010, at Reel 4236, Frame 0537; and

WHEREAS, Grantor has requested that Sun Pace release its security interest in and lien on all of Grantor's right, title and interest in, to and under the Secured Trademark of Schedule A and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Sun Pace hereby releases its security interest in and lien on all of Grantor's right, title and interest in, to and under the following Secured Trademark:
 - a. the Trademark listed on Schedule A annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by said Trademark; and
 - b. all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of said Trademark, or (b) injury to the goodwill associated with said Trademark.
2. Sun Pace hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Sun Pace all of Sun Pace's right, title and interest in and to such Secured Trademark.
