**NOTICE OF RELEASE OF  
SECURITY INTEREST IN UNITED STATES TRADEMARKS

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, Collateral Agent hereby relinquishes, releases and discharges without recourse, representation or warranty all of its security interest in the Trademarks, whether granted pursuant to the Trademark Security Agreement or any other agreement or document delivered in connection with or related to that Trademark Security Agreement, or arising under applicable law, and the Collateral Agent hereby reassigns any and all right, title and interest (if any) that the Collateral Agent may have in the Trademarks to Assignor.

The Collateral Agent agrees, at the Assignor's expense, to cooperate with the Assignor, to execute, deliver and file any additional documents, and to provide the Assignor with (i) the information reasonably available to it, and (ii) any additional authorization reasonably required or desirable to effect the release, relinquishment or discharge of the Collateral Agent's security interest in the released collateral described herein.
