## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of June 25, 2015 (“Release”), is made by UBS AG, Stamford Branch, as Collateral Agent (“Collateral Agent”), in favor of Ducommun Incorporated, a Delaware corporation, Ducommun Labarge Technologies, Inc., a Delaware corporation, and LaBarge Acquisition Company, Inc., a Missouri corporation (individually, a “Pledgor”, and, collectively, the “Pledgors”).

**WHEREAS**, pursuant to that certain Security Agreement dated as of June 28, 2011 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Security Agreement”) by and among the Pledgors, Collateral Agent, and others party thereto and the Trademark Security Agreement dated as of June 28, 2011 (“Trademark Security Agreement”) by and among the Pledgors and Collateral Agent, each Pledgor pledged and granted to the Collateral Agent, for the benefit of the Secured Parties, a lien on and security interest in and to all of such Pledgor’s right, title and interest in, to and under the Trademarks of such Pledgor, all Goodwill associated with such Trademarks, and all Proceeds of any and all of the foregoing (“Trademark Collateral”); and

**WHEREAS**, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on July 8, 2011 at Reel 4578 Frame 0853, June 29, 2011 at Reel 4572 Frame 0053, and June 29, 2011 at Reel 4572 Frame 0073.

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Collateral Agent, on behalf of the Secured Parties, and Pledgors agree as follows:

**SECTION 1. Defined Terms.** Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or Trademark Security Agreement.

**SECTION 2. Termination and Release.** Collateral Agent, on behalf of the Secured Parties, hereby:

(a) absolutely, unconditionally and irrevocably terminates the Trademark Security Agreement, and any other agreement under which any Pledgor has granted a collateral mortgage, pledge, hypothecation, grant, assignment, lien, or security interest in, to, and under the Trademark Collateral;

(b) absolutely, unconditionally and irrevocably terminates, cancels, forever discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the right, title, and interest in, to, and under the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto; and

(c) executes and delivers this Release without recourse, representations or warranties of any kind or nature.

**IN WITNESS WHEREOF**, the Collateral Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.


