## TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of June 17, 2015, by **ONE CONANT CAPITAL LLC**, in its capacity as a lender (in such capacity, "**Grantee**"). Capitalized terms used but not defined herein shall have the meanings assigned to such terms in the Assignment described below.

W I T N E S S E T H:

WHEREAS, Grantee and BIRDDOG SOLUTIONS, INC., a Nevada corporation ("**Grantor**"), were parties to that certain Trademark Security Agreement dated as of July 19, 2007 (the "**Assignment**"), pursuant to which Grantor granted a security interest to Grantee in certain Trademark Collateral as security for certain obligations owing by Grantor to Agent, including, without limitation, the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the United States Patent and Trademark Office on July 26, 2007, at Reel 3590 Frame 0289; and

WHEREAS, Grantor has requested that Grantee release its security interest in and lien on the Trademark Collateral and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases and discharges fully its security interest in and lien on all of Grantor's right, title and interest in and to the Trademark Collateral.
2. Grantee hereby releases its security interest in and lien on the Trademark Collateral.
3. Grantee hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Grantee, all of Grantee's right, title and interest in and to the Trademark Collateral.
