Pursuant to Section 11.06 of the Massachusetts Business Corporation Act (the "MBCA"), the undersigned corporations, Partners & Simons, Inc., a Massachusetts corporation (the "Disappearing Corporation"), and Partners & Simons, Inc., a Delaware corporation, do hereby certify that:

1. Constituent Corporations. The name, state of organization and date of organization of each of the constituent corporations is set forth as follows:

2. Name of Surviving Corporation. The name of the corporation surviving the merger is Partners & Simons, Inc., organized under the laws of Delaware (the "Surviving Corporation").

3. Authorization of the Surviving Corporation. The participation of the Surviving Corporation in the merger was duly authorized by the laws under which the Surviving Corporation was incorporated, all action required by such laws and its certificate of incorporation.

4. Approval of Plan of Merger by Disappearing Corporation. A plan of merger has been approved, adopted, certified, executed and acknowledged by the board of directors and the shareholders of the Disappearing Corporation pursuant to Section 11.04 of the MBCA and in accordance with the Disappearing Corporation's articles of organization.


5. Effective Date. This Certificate of Merger shall be effective upon its filing with the Secretary of the Commonwealth of Massachusetts.

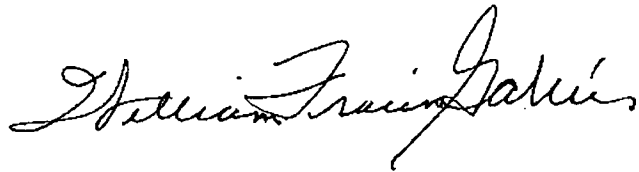
