**RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT**

June 25, 2015

**WHEREAS, Tegile Systems, Inc.**, a Delaware corporation (the “*Grantor*”), granted a security interest in favor of Silicon Valley Bank (in such capacity, the “*Bank*”), and a lien upon certain trademarks and trademark applications pursuant to that certain Intellectual Property Security Agreement dated December 19, 2014 by Grantor in favor of the Bank (the “*Agreement*”), which was recorded in the United States Patent and Trademark Office on December 22, 2014 at Reel 005424, Frame 0490;

**WHEREAS**, the Grantor has requested and Bank has agreed to release and reassign to Grantor its interest in all of Grantor’s trademarks and trademark applications including the trademarks identified in **Exhibit A** hereto and made a part hereof; and

**NOW, THEREFORE**, for good and valuable consideration, receipt of which is hereby acknowledged, the Bank hereby:


1. releases, terminates and discharges all liens and security interests in all of Grantor’s right, title and interest in, to and under the Trademarks (as defined in the Agreement) including those trademarks identified in **Exhibit A** hereto;
2. authorizes and requests that the Commissioner for Trademarks at the United States Patent and Trademark Office note and record the existence of the release hereby given; and
3. agrees that it shall, at the Grantor’s sole cost and expense and at the Grantor’s, or their successor’s or assign’s, reasonable request, execute, acknowledge and deliver to the Grantor all further releases and other documents, and take all other actions necessary or reasonably desirable for the release of such security interest.
