RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release") is made as of this 29th day of June 2015, by GOLUB CAPITAL LLC, in its capacity as administrative agent ("Administrative Agent"), in favor of MARATHON DATA OPERATING CO., LLC, a Delaware limited liability company (the "Company"), as successor to VANTAGE POINT MAPPING, INC., a Missouri corporation (the "Original Holder").

WHEREAS, the Original Holder was the original applicant and registrant of the trademark listed on Schedule I hereto and the owner of the Trademark Collateral (as defined below) and has since assigned the same to the Company.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Administrative Agent hereby unconditionally and expressly releases, terminates, cancels, reassigns and extinguishes its liens on and security interests in all of the Company's right, title and interest in and to the following to the extent such liens and security interests secure the Obligations (referred to herein as the "Trademark Collateral"): (i) all of its trademarks and all intellectual property licenses providing for the grant by or to Company or any right under any trademark, including, without limitation, those referred to on Schedule I hereto; (ii) all renewals and extensions of the foregoing; (iii) all goodwill of the business connected with the use of, and symbolized by, each such trademark; and (iv) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

The liens and security interests released and terminated hereby were established under and pursuant to that certain Trademark Security Agreement dated December 31, 2014


("Security Agreement"), executed by Original Holder in favor of Administrative Agent and recorded with the United States Patent and Trademark Office on December 31, 2014 at reel/frame 5433/0147. The Administrative Agent hereby terminates the Security Agreement and terminates, discharges, releases, cancels, reassigns, grants and conveys to the Company, any and all of the Administrative Agent's right, title and interest in and to the Trademark Collateral.

The Administrative Agent hereby authorizes the recordation of this Release with the United States Patent and Trademark Office and any other applicable registry.
