## TERMINATION OF TRADEMARK SECURITY AGREEMENT

WHEREAS, Performance Technologies, Incorporated, a Delaware corporation, located at 140 Canal View Boulevard, Rochester, New York 14623 (the "Grantor") and Bank of America, N.A., located at 100 Federal Street, Mail Code MA5-100-08-13, Boston, Massachusetts 02110 (the "Administrative Agent"), entered into a certain Notice of Grant of Security Interest in Trademarks (the "Agreement"), dated as of June 27, 2014, which was recorded in the United States Patent and Trademark Office on September 11, 2014 at Reel 5361 and Frame 0105, that by its terms granted the Administrative Agent a security interest in certain intellectual property listed in Exhibit A (the "Trademark") to the Agreement and all trademark applications and trademark registrations acquired or arising after the date of the Agreement;


WHEREAS, the Administrative Agent has agreed to release the security interest in that certain Trademark granted by Grantor.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, effective as of even date herewith, the Administrative Agent hereby reassigns to the Grantor the interest in the Trademark listed on Schedule A attached hereto in which the Administrative Agent was granted a security interest under the Agreement. The Administrative Agent also hereby releases its security interest in the Trademark listed in Schedule A attached hereto. The Administrative Agent further agrees, for itself, its successors and assigns, to execute such further documents and to perform such further lawful acts as may reasonably be requested by the Grantor, to effectuate this release.

The Administrative Agent acknowledges that it is the purpose of this document to memorialize the aforementioned release of its security interest in the Trademark listed in Schedule A attached hereto in a form suitable for recordation in the United States Patent and Trademark Office and hereby consents to the recording of this document in the United States Patent and Trademark Office.
