SECOND SUPPLEMENT TO INTELLECTUAL PROPERTY AGREEMENT

This Second Supplement to Intellectual Property Security Agreement (“*Second Supplement*”) is made as of June 29, 2015 by YODLE, INC. (“Grantor”) in favor SILICON VALLEY BANK (“Bank”).

WHEREAS, the Grantor executed and delivered an Intellectual Property Security Agreement dated September 29, 2011 and recorded with the United States Patent and Trademark Office on September 30, 2011 at Reel 4634, Frame 0015 (as amended of record from time to time hereinafter, the “*Agreement*”) in favor of the Bank, pursuant to which the Grantor pledged, assigned and granted a security interest in certain Trademarks and/or Trademark Applications (as defined therein);

WHEREAS, the Grantor executed and delivered a First Amendment to Intellectual Property Security Agreement dated September 4, 2012 and recorded with the United States Patent and Trademark Office on September 6, 2012 at Reel 4857, Frame 0228 (the “*Amendment*”) in favor of the Bank;

WHEREAS, the Grantor executed and delivered a Supplement to Intellectual Property Security Agreement dated February 6, 2015 and recorded with the United States Patent and Trademark Office on February 6, 2015 at Reel 5455, Frame 0230 (the “*Supplement*”, and together with the Agreement and Amendment, collectively the “*Grant*”) in favor of the Bank;

WHEREAS, Grantor developed additional Trademarks and/or Trademark Applications and desires to hereby confirm the pledge of, and the grant of a security interest in, such additional Trademarks and/or Trademark Applications in favor of Bank; and

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:


1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Agreement.
2. Supplement to Exhibit C. Exhibit C to the Grant is hereby supplemented, but not replaced, by Exhibit C-1 annexed hereto.
3. Miscellaneous:
 - a. Except as provided herein, all terms and conditions of the Grant remain in full force and effect.
 - b. This Second Supplement covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.
