TRADEMARK ASSIGNMENT AGREEMENT

This **TRADEMARK ASSIGNMENT AGREEMENT** (this “Trademark Assignment Agreement”), effective as of June 30, 2015, is by and between TouchTunes Music Corporation, a Delaware corporation (the “Assignee”), and TouchTunes Media Corporation, a Texas corporation (the “Assignor”).

WHEREAS, the Assignee and Assignor are Subsidiaries of TouchTunes Interactive Networks, Inc.; and

WHEREAS, the Assignor wishes to sell, assign, transfer and deliver to the Assignee, and the Assignee wishes to purchase and acquire from the Assignor, all of the Assignor’s right, title and interest in, to and under the trademark listed in Schedule 1 hereto, together with all goodwill associated therewith, and all applications, registrations and renewals in connection therewith (the “Trademark”);

NOW, THEREFORE, in consideration of the foregoing, the covenants and agreements contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties to this Trademark Assignment Agreement hereby agree as follows:

Section 1. Assignment and Assumption. The Assignor hereby sells, conveys, assigns, transfers and delivers to the Assignee all of the Assignor’s right, title and interest in and to the Trademark, together with any and all goodwill associated therewith.

Section 2. Recordation. This Trademark Assignment Agreement has been executed and delivered by the Assignor for the purpose of recording the assignment herein with the appropriate government entity.


Section 3. Governing Law. This Trademark Assignment Agreement and any claim or controversy hereunder shall be governed by and construed in accordance with the laws of the State of Delaware without giving effect to the principles of conflict of laws thereof.

Section 4. Counterparts. This Trademark Assignment Agreement may be signed in counterparts (including via facsimile or pdf) with the same effect as if the signatures to each counterpart were upon a single instrument, and all such counterparts together shall be deemed an original of this Trademark Assignment Agreement.


