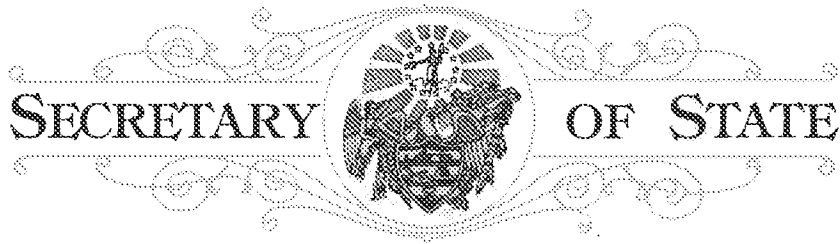

**SECOND AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION  
OF  
WESTROCK COFFEE HOLDINGS, LLC**

December 31, 2013

1. Westrock Coffee Holdings, LLC (the "Company"), a limited liability company organized and existing under the Small Business Entity Tax Pass Through Act of the State of Arkansas, Ark. Code. Ann. § 4-32-101 et seq., was organized on April 29, 2009 under the name "Rwanda Trading Company, LLC." On April 28, 2010 the Company changed its name to "Westrock Coffee Company, LLC" upon the filing of its Amended and Restated Articles of Organization with the Arkansas Secretary of State.

2. The sole member of the Company has approved the amendment and restatement of the Company's Amended and Restated Articles of Organization to change (i) the Company's name from "Westrock Coffee Holdings, LLC" to "Westrock Coffee Company, LLC" and (ii) the Company's registered agent and principal address.

3. The sole member of the Company hereby adopts the following Second Amended and Restated Articles of Organization of the Company:

First: The name of the Limited Liability Company shall be Westrock Coffee Company, LLC.

Second: Address of the registered office of the Limited Liability Company which may be, but need not be, the place of business shall be: 900 South Shackleford Road, Suite 215, Little Rock, Arkansas 72211.

Third: The name and address of the registered agent shall be: T. Christopher Pledger, 900 South Shackleford Road, Suite 200, Little Rock, Arkansas 72211.


Fourth: Management of the Limited Liability Company is vested in its member(s). As part of its authority to transact business generally, the member(s) of the Limited Liability Company may open bank accounts for the Limited Liability Company, sign loans or leases on behalf of the Limited Liability Company, apply for a tax identification number, or engage in any transaction necessary to manage the Limited Liability Company.
