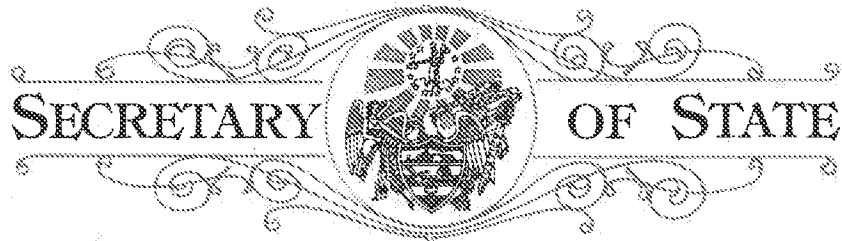

**SECOND AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
WESTROCK COFFEE, LLC**

December 31, 2013

1. Westrock Coffee, LLC (the "Company"), a limited liability company organized and existing under the Small Business Entity Tax Pass Through Act of the State of Arkansas, Ark. Code. Ann. § 4-32-101 et seq., was organized on July 24, 2009 under the name "CL Acquisition, LLC" upon the filing of its Articles of Organization with the Arkansas Secretary of State. On July 28, 2009, the Company changed its name to Coffee Legends, LLC upon the filing of a Certificate of Amendment to its Articles of Organization. On May 3, 2010, the Company changed its name to "Westrock Coffee, LLC" upon the filing of Amended and Restated Articles of Organization.

2. The undersigned as sole member of the Company has approved the amendment and restatement of the Company's Articles of Organization to, among other things, (i) change the Company's name from "Westrock Coffee, LLC" to "Westrock Coffee Roasting, LLC" and (ii) change the registered agent of the Company.

3. The undersigned hereby adopts the following Second Amended and Restated Articles of Organization of the Company:

First: The name of the Limited Liability Company shall be Westrock Coffee Roasting, LLC.

Second: Address of the registered office of the Limited Liability Company which may be, but need not be, the place of business shall be: 900 South Shackleford Road, Suite 215, Little Rock, Arkansas 72211.

Third: The name and address of the registered agent shall be: T. Christopher Pledger, 900 South Shackleford Road, Suite 200, Little Rock, Arkansas 72211.

Fourth: Management of the Limited Liability Company is vested in its member(s). As part of its authority to transact business generally, the member may open bank accounts for the Limited Liability Company, sign loans or leases on behalf of the Limited Liability Company, apply for a tax identification number, or engage in any transaction necessary to manage the Limited Liability Company.
