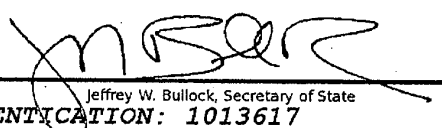

State of Delaware Certificate of Merger

This Certificate of Merger, dated this 23rd day of December, 2013, has been executed by Ravago Americas LLC, a Delaware limited liability company, f/k/a Ravago Shared Services LLC, a Delaware limited liability company, and f/k/a Muehlstein Administrative Services LLC, a Delaware limited liability company ("Ravago Americas") pursuant to Title 6, Section 18-209 of the Delaware Limited Liability Company Act and Section 264 of the Delaware General Corporation Law.

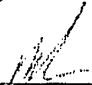
1. As of the Effective Time (as defined below), each of Ravago Manufacturing Americas, LLC, a Delaware limited liability company ("RMA"), Muehlstein Polymers International Inc., a Delaware corporation ("MPI"), American Compounding Specialties, LLC, a Delaware limited liability company ("ACS"), Muehlstein LLC, a Delaware limited liability company ("MLLC"), and Amco Polymers LLC, a Delaware limited liability company f/k/a Amco Distribution LLC f/k/a Pegasus Polymers Benelux Inc. ("Amco"), will be merged into Ravago Americas (the "Merger"). Ravago Americas shall be the surviving entity (the "Surviving Entity") and the separate and independent legal existence of RMA, ACS, MPI, MLLC, and Amco, respectively, shall cease as of the Effective Time. In connection with the Merger, the name of the Surviving Entity shall remain the same.
2. The effective time of the Merger will be December 31, 2013 at 11:50:00 PM EST (the "Effective Time").
3. Each of the Merged Entities and Ravago Americas, respectively, have approved, adopted, certified, executed, and acknowledged that Agreement and Plan of Merger between them ("Agreement of Merger").
4. The Certificate of Formation of the Surviving Entity (the "Certificate"), and the Operating Agreement (the "OA"), as each are in effect immediately prior to the Effective Time, shall continue in full force and effect as the Certificate and OA of the Surviving Entity, unless and until amended and/or amended and restated in accordance with their respective terms and provisions and applicable law.
5. The principal office of the Surviving Entity shall be at 1900 Summit Tower Blvd, Suite 900, Orlando, FL 32810, wherein a copy of the Agreement and Plan of Merger shall be kept.
6. The Surviving Entity shall furnish, upon request and at its sole cost, a copy of the Agreement and Plan of Merger to any member or shareholder of the Merged Entities and/or Ravago Americas.
