Secured Party hereby releases and discharges any and all security interests in and to the Collateral, including, but not limited, to the Trademarks, and hereby waives any and all claims or interest it has or might have in and with respect to the Collateral, including, but not limited, to the Trademarks. 2. Representation and Warranty. Secured Party represents and warrants that it has the power and authority to execute and perform under this Release Agreement.


3. Miscellaneous. This Release Agreement represents the complete understanding of the parties and supersedes any prior or contemporaneous agreement regarding the Trademarks.


