

## RELEASE OF SECURITY AGREEMENT

THIS RELEASE dated as of **June 10, 2015** (this "Release") is made by U.S. Bank National Association, a National Association, acting in its capacity as secured party (in such capacity, the "Secured Party") under that certain **Security Agreement**, dated as of **March 11, 2013** and recorded **March 13, 2013 in Reel 4980 Frame 0752** in the records of the United States Patent and Trademark Office (as amended, supplemented or modified and in effect from time to time, the "Security Agreement"), among **Roger Garments, LLC**, (the "Debtor") and the Secured Party;
