SUMMARIZED AGREEMENT FOR THE PURPOSE OF REGISTERING THE TRANSFER OF BRAND RIGHTS ("SUMMARIZED AGREEMENT") ENTERED INTO BY AND BETWEEN, FOR THE ONE PARTY, CENTRO COMERCIALIZADOR COSPHAR, S.A. DE C.V. (HEREAFTER THE "ASSIGNEE"), REPRESENTED BY MR. FERNANDO GARCIA ZURITA BECERRIL, AND FOR THE OTHER PARTY, ROUX LABORATORIES, INC. (HEREAFTER "ROUX"), AND FERMODYL PROFESSIONALS, INC. (HEREAFTER "FERMODYL INC." AND TOGETHER WITH ROUX THE "ASSIGNOR" AND/OR THE "ASSIGNORS"), AND FOR ANOTHER PARTY, COLOMER MEXICO, S.A. DE C.V. (HEREAFTER "COLOMER MEXICO", AND TOGETHER WITH THE ASSIGNEE AND THE ASSIGNORS AS THE "PARTIES" AND EACH INDIVIDUALLY ONE "PARTY"), REPRESENTED BY MR. HANS MARTEAU, IN ACCORDANCE WITH THE FOLLOWING:

#### RECITALS

- I. The Assignors, through their legal representative, declare that:
  - a) They are companies which were legally established pursuant to the laws of the United States of America, and its representatives have sufficient authority to execute this Summarized Agreement, on their behalf and representing them, and said authority has not been limited or revoked in any way as of the date of this Agreement.
  - b) Roux is the legitimate and sole holder in the United Mexican States ("Mexico") and in other countries of the brands, files, registrations, applications and domain names described in the document attached to this Summarized Agreement as Annex I(b) (hereafter the "Roux brands"), which are free from any encumbrance or limitation whatsoever, and free from any authorization or usage rights held by third parties.



- c) Fermodyl Inc. is the legitimate and sole holder in Mexico and in other countries of the brands, files, registrations, applications and domain names described in the document attached to this Summarized Agreement as Annex I(c) (hereafter the "**Fermodyl Inc. Brands**", and together with the Roux Brands referred to as the "**Brands**"), which are free from any encumbrance or limitation whatsoever, and free from any authorization or usage rights held by third parties.
- d) Their domiciles are located at 5344 Overmyer Drive, Jacksonville, Florida, 32254, United States of America.

II. Colomer Mexico, through its legal representative, declares that:

- a) It is a company that was founded and exists according to Mexican law, and its representative has sufficient authority to enter into this Summarized Agreement, and this authority has not been revoked or modified in any manner.
- b) Its domicile is located at WTC-Almeda Park, Tirso de Molina 40, 08940 Cornella de Llobregat, Spain.

III. The Assignee, through its legal representative, declares that:

- a) It is a company that was founded and exists according to Mexican law, and its representative has sufficient authority to enter into this Summarized Agreement, and this authority has not been revoked or modified in any manner.
- b) Its domicile is located at Insurgentes Sur No. 950, Offices 901, 902 and 903, Colonia del Valle, C.P. 03100, Delegacion Benito Juarez, in Mexico, Federal District.



Based on the preceding statements, the Parties agree to the following Clauses:

FIRST. The Assignors in this act assign and transfer to the Assignee, free of any encumbrance, burden or limitation of ownership, license or franchise whatsoever, and free of any third-party rights, the totality of the rights, privileges, benefits, expectations of rights, titles and established and derived interests and industrial and intellectual property of the Brands in Mexico and abroad, as well as the domain name [www.fermodyl.com.mx](http://www.fermodyl.com.mx)

SECOND. The consideration agreed to in exchange for the transfer of the Brands will be paid according to the terms of the contract executed by the Parties in a separate document.

THIRD. The Assignee will individually assume the expenses incurred to register the industrial property rights to the Brands with the Mexican Industrial Property Institute (the "**IMPI**"), as well as with any other governmental agency with relevant authority in each of the jurisdictions in which the Brands will be registered in foreign countries.

FOURTH. The Assignors agree that as of the execution of this Summarized Agreement, they will abstain from engaging in any act that could invalidate or affect the Brands or the ownership thereof, and will not obtain, nor will they attempt to obtain, registration of any trademarks that are similar to the Brands to the point of inducing confusion, in any jurisdiction, whether in Mexico or abroad.

FIFTH. The Assignors in this act bestow upon the Assignee the power to file this Summary Agreement with the IMPI, and with any relevant governmental authority in any of the foreign jurisdictions in which the Brands will be registered.




For these purposes, the Assignors agree in this act to execute, sign, ratify and/or sign any document, filing, application, notification, contract and/or agreement, including granting necessary powers of attorney, that are required pursuant to applicable laws and regulations, and/or in accordance with any requirement imposed by the relevant governmental authorities in Mexico or abroad, to file and/or register the transfer described in this Summarized Agreement with any of said governmental authorities.

The Parties agree that this Summarized Contract will be registered with the IMPI, and therefore they grant in this act, jointly, a special irrevocable power of attorney upon Juan Enrique Paez Torres and Gerardo Acevedo Mendez, so that either of them, indistinctly, may take whatever actions are necessary to register this agreement, and to obtain the official documentation issued by the IMPI confirming said registration and its effects.

SIXTH. For all matters related to the interpretation and validity of this Summarized Contract, the Parties expressly submit to the competent laws and courts of Mexico City, Federal District, in the United Mexican States.

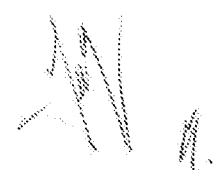

III. Declara la Cesionaria, por conducto de su apoderado legal, que:
