**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of July   , 2015 ("Effective Date") by and among Smith Brothers, Inc. a Texas corporation ("Grantor") and Citizens Bank, N.A. (f/k/a RBS Citizens, National Association) (the "Secured Party").

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby terminates the Trademark Security Agreement (and the Security Agreement, to the extent any terms or provisions thereunder are still in effect), and relinquishes, releases, and returns unto Grantor the continuing security interest in and to, and lien on, the Collateral and otherwise assigns, grants and conveys to Grantor, without recourse, any and all right, title and interest Secured Party may have in, to or under to the Collateral in order to revest in Grantor full and unencumbered title to said Collateral.
