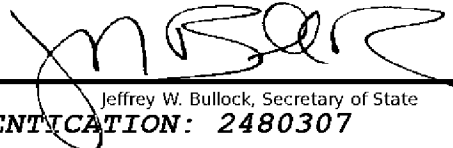

Pursuant to Title 8, Section 251(c) of the Delaware General Corporation Law, the undersigned corporation executed the following Certificate of Merger:

The name of this corporation (the "**Corporation**") is: OPTIV SECURITY INC."

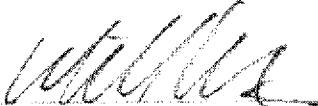
FIFTH: The merger is to become effective on JULY 1, 2015.
