### RELEASE OF SUPPLEMENT TO TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF SUPPLEMENT TO TRADEMARK SECURITY AGREEMENT (this "Release") is made as of June 30, 2015 (the "Effective Date") by Obsidian Agency Services, Inc., in its capacity as collateral agent (together with its successors, "Collateral Agent") for the benefit of the Grantors. All capitalized terms used berein but not otherwise

WHEREAS, pursuant to the terms and conditions of that certain (i) Second Amended and Restated Guarantee and Collateral Agreement dated as of February 28, 2013, among the grantors party thereto and Collateral Agent, (ii) Second Amended and Restated Trademark Security Agreement dated as of February 28, 2013, among the grantors party thereto and Collateral Agent and (iii) Supplement No. 1 to Second Amended and Restated Trademark Security Agreement dated as of February 13, 2014, among the grantors party thereto and Collateral Agent (the "Supplement to Trademark Security Agreement"), the Grantor pledged, assigned and granted to Collateral Agent a continuing security interest in all of its right, title and interest in and to the Trademark Collateral including, without limitation, the trademark registrations and applications set forth on Schedule I hereto, along with the goodwill associated therewith; and

**WHEREAS,** the Supplement to Trademark Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on February 18, 2014 at Reel 5218 and Frame 0312.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby terminates the Supplement to Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademark Collateral, including but not limited to the Trademark Collateral listed under <u>Schedule I</u> attached hereto, and including the goodwill exclusively symbolized thereby, all renewals of the foregoing, and all proceeds of the foregoing, including any claims against third parties for past, present or future infringement or dilution of the Trademark Collateral.

If and to the extent Collateral Agent has acquired any right, title or interest to any of the Trademarks, it hereby re-assigns and re-transfers such rights, title or interest to the Grantor.

Collateral Agent shall take all further actions, and provide to the Grantor and their respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor to more fully and effectively effectuate the purposes of this Release, all at the expense of the Grantor.

This Release shall be governed by and construed in accordance with, the laws of the State of New York.
