TRADEMARK ASSIGNMENT

NOW, THEREFORE, in consideration of ten dollars (\$10.00), and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor assigns to Assignee all right, title, and interest in and to the Mark, together with all of the goodwill relating thereto, and all rights of action and claims for past infringement thereof.
