RELEASE AND TERMINATION OF SECURITY AGREEMENT

In consideration of the payment of all indebtedness and amounts secured by that certain First Amendment to Trademark Security Agreement made as of September 11, 2006, by and between Merrill Lynch Capital, a Division of Merrill Lynch Business Financial Services Inc., as Administrative Agent, a Delaware Corporation, with a principal place of business at 222 North LaSalle Street, 16th Floor, Chicago, Illinois 60601 (the "Bank"), and Microgroup, Inc., formerly Microgroup Acquisition Company a Delaware Corporation, with a principal place of business at 7 Industrial Park Road, Medway Massachusetts 02053 (the "Borrower"), which First Amendment to Trademark Security Agreement was filed with the United States Patent and Trademark Office on January 8, 2007, and recorded in Reel 3456, Frame 0707, of the Trademark Assignment Records, the Bank hereby releases and discharges all of its right, title and interest in and to the above-described First Amendment to Trademark Security Agreement, including the security interest and conditional assignment created and existing thereunder on the property described in and covered thereby, and reassigns to the Borrower any right, title and interest of the Bank in and to the "Collateral" described therein, including the right to recover for past infringement of any of the Collateral and the goodwill of the business in connection with which the Collateral is used and which is symbolized by any of the Collateral.

Reference is made to the above-described First Amendment to Trademark Security Agreement and the recordation thereof for all purposes in connection herewith.
