**TRADEMARK ASSIGNMENT AGREEMENT**

WHEREAS, Assignee desires to acquire all right, title and interest in and to the Mark as a successor to the portion of Assignor's business to which the mark pertains.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign and transfer to Assignee all right, title and interest in and to the Mark, together with the goodwill symbolized by said Mark as a successor to the portion of Assignor's business to which the mark pertains, and Assignor hereby agrees to take such other actions as are reasonably necessary to transfer and assign the Mark to Assignee, including, without limitation, registering this Trademark Assignment Agreement with the United States Patent and Trademark Office.
