## TRADEMARK RELEASE

THIS TRADEMARK RELEASE is made as of July 1, 2015, by Madison Capital Funding LLC as agent for the lenders (in such capacity, "Agent"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

### WITNESSETH:

WHEREAS, TIDI Products, LLC, a Delaware limited liability company ("Grantor") and Agent were parties to that certain Trademark Security Agreement dated as of December 13, 2013 (the "Security Agreement"), pursuant to which Grantor granted a security interest to Agent in certain trademarks ("Trademarks") and Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Agent, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on December 16, 2013, at Reel 5177, Frame 0308; and

WHEREAS, Grantor has requested that Agent release its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademarks and Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged by the parties to the Security Agreement:

1. Agent hereby releases, for itself and on behalf of the lenders, its security interest in and lien on all of Grantor's right, title and interest in and to the following (collectively the "Trademark Collateral"):

(a) each Trademark set forth on Schedule 1 hereto, together with any reissues, continuations or extension thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

(b) all products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future (i) infringement or dilution of such Trademark or (ii) injury to the goodwill associated with each such Trademark.
