**ASSIGNMENT OF
INTELLECTUAL PROPERTY**

THIS ASSIGNMENT OF INTELLECTUAL PROPERTY (this "Assignment") is made as of June 12, 2015, by and between WEYERHAEUSER NR COMPANY, a Washington corporation ("WNR"), WNR COYOTE HOLDINGS, LLC, a Nevada limited liability company (f/k/a Pardee Coyote Holdings I, LLC, a Nevada limited liability company) (collectively, with WNR, "Assignor") and COYOTE SPRINGS NEVADA, LLC, a Nevada limited liability company.

RECITALS:

A. WHEREAS, on or about June 30, 2014, Pardee Homes of Nevada, a Nevada corporation transferred all its right, title, and interest in the Coyote Springs project (the "Project") to WNR.

B. WHEREAS, on or about June 12, 2015, Assignor transferred all its right, title, and interest in the Project to Coyote Springs Nevada, LLC ("Transfer Date").

C. WHEREAS, the parties desire to memorialize the assignment of Assignor's rights and interests in intellectual property used solely in connection with the Project to Coyote Springs Nevada, LLC.

NOW, THEREFORE, for valuable consideration, the receipt of which is acknowledged, the parties agree to the following:

1. Effective on the Transfer Date, Assignor assigns to Coyote Springs Nevada, LLC all its rights and interests in any intellectual property (including corporate and trade names, Trademarks, and websites/urls) used solely in connection with the Project, and any goodwill associated therewith, including, without limitation, all of Assignor's rights therein in any location in the United States, including that certain trademark named "The Villages of Coyote Springs" and all common-law rights associated therewith.

2. This Assignment may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute but one agreement.




