**RELEASE OF SECURITY INTEREST**

Assignee hereby represents that it has the authority to grant the releases and discharges set forth herein without the joinder of any other party.



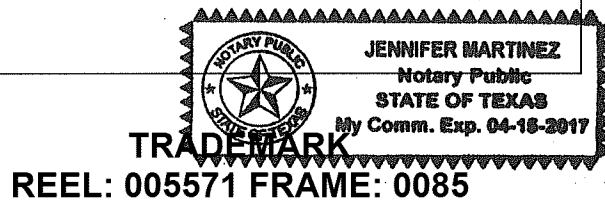
