RELEASE OF TRADEMARK SECURITY INTEREST

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, LBC Credit Partners II, L.P., as agent, a limited partnership (the "Agent"), whose address is Cira Centre, 2929 Arch Street, Philadelphia, PA 19104, pursuant to that certain Term Loan, Security and Guaranty Agreement dated as of December 21, 2011, by and among the Loan Parties (as defined therein) from time to time party thereto (each a "Grantor" and collectively, the "Grantors"), the Agent and the Lenders (as defined therein), (as amended on May 9, 2012, October 22, 2012 and on February 25, 2013, and as may be further amended restated or otherwise modified from time to time, the "Loan Agreement"), does hereby unconditionally and expressly release, terminate and forever discharge and extinguish any and all of its right, title and interest in and to any and all liens and security interests it may have under all intellectual property collateral identified in the Loan Agreement and the Notice of Grant of Security Interest in Trademarks dated as of December 21, 2011 among the Agent and the undersigned Grantor, American & EFIRD Enterprises, Inc. (the "Security Agreement"), including the trademarks listed on Exhibit A attached hereto, (the "Released Collateral"), arising from the Loan Agreement and the Security Agreement, which was recorded in the United States Patent and Trademark Office ("PTO") on or about December 21, 2011, against the United States trademarks listed on Exhibit A at Reel/Frame Numbers 4684/0070. The Agent hereby releases, retransfers and reassigns to the undersigned Grantor the security interest and all of the Agent's right, title and interest in, to and under the Released Collateral. The Agent will execute and deliver, at the request and cost of Grantor, such further instruments, documents and release forms as Grantor may reasonably request to more effectively release, terminate, discharge, and extinguish any such liens and security interests upon such Released Collateral.

This Release of Trademark Security Interest shall be binding upon the Agent's legal representatives, assigns and successors. The Agent hereby authorizes and requests the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release of Trademark Security Interest.
