## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**WHEREAS**, in connection with the Credit Agreement, Grantor executed that certain Grant of Security Interest in the United States Trademarks, dated as of July 31, 2013 (as heretofore amended, restated, supplemented or otherwise modified, the "Trademark Security Agreement"), which was duly recorded on August 2, 2013, at Reel 5084/ Frame 0563 with the United States Patent and Trademark Office, and granted to Agent a continuing security interest in and a continuing lien upon, all of Grantor's right, title and interest in and to all trademarks and service marks, registrations and applications for registration and any renewals thereof, together with the goodwill associated therewith, including, without limitation, as set forth on Schedule A attached hereto (collectively, the "Trademarks"); and


**WHEREAS**, Agent wishes to release and restore all right, title and interest in and to the Trademarks to Grantor and to dissolve those liens and encumbrances with respect to the Trademarks created by the Trademark Security Agreement, the Credit Agreement and any other Loan Document.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of itself and the Lenders, does hereby fully and finally release and relinquish all security interests and liens in the Trademarks granted to Agent by Grantor and assigns to Grantor any rights, title, or interests it may have under such Trademark Security Agreement in, to or under any of the Trademarks or any goodwill associated therewith, without recourse or representation or warranty, express or implied, of any kind.
