**PARTIAL RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY**

THIS PARTIAL RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY is made as of July 2, 2015, by JPMorgan Chase Bank, N.A., as administrative agent (the "Administrative Agent").

WHEREAS, StoneRiver RegEd, Inc., a North Carolina corporation, and Compliance Assurance Corporation, a Delaware corporation (collectively, the "Grantors"), entered into that certain Intellectual Property Security Agreement dated as of September 12, 2014 (the "IP Security Agreement"), which was recorded on September 15, 2014 in the United States Patent and Trademark Office at Reel 5362, Frame 0416 and Reel 033740, Frame 0672, pursuant to which certain of the Grantors granted to the Administrative Agent, a security interest in and lien on all right, title and interest of such Grantors in certain Trademarks, Patents and Copyrights (as defined therein), including the Trademarks set forth on Schedule A attached hereto ((i) the Trademarks set forth on Schedule A attached hereto, together with the goodwill associated with such Trademarks, (ii) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing and (iii) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages, are herein referred to as the "Released IP"), to secure the performance of certain obligations;

WHEREAS, such Grantors have requested and Administrative Agent has consented to release its security interest in the Released IP.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, Administrative Agent does hereby, without representation, warranty or recourse, fully release, terminate, relinquish and discharge its security interest in, to and under the Released IP (but Administrative Agent does hereby expressly reserve and retain all of its right, title, interest and liens granted by the IP Security Agreement in all Collateral (as defined in the IP Security Agreement), including Trademarks, Patents and Copyrights, other than the Released IP).

Administrative Agent agrees, at the sole cost and expense of the Grantors, to perform all necessary acts to affect the release and termination of its security interest and lien in the Released IP, including, but not limited to the recording, filing and entering into any agreements, documents, forms or papers needed to accomplish such release and termination.
