At any time upon ASSIGNEE'S written request, ASSIGNOR shall take any and all steps without undue delay, to execute, acknowledge and deliver to ASSIGNEE any and all further instruments and assurances necessary or expedient to vest the aforesaid rights in ASSIGNEE and to facilitate ASSIGNEE'S enjoyment and enforcement of said rights and causes of action.

ASSIGNOR hereby constitutes and appoints ASSIGNEE as ASSIGNOR'S true and lawful attorney in fact, with full power of substitution in ASSIGNOR'S name and scope, to take any and all steps, including proceedings at law, in equity or otherwise, to execute, acknowledge and deliver any and all instruments and assurances necessary or expedient in order to vest or perfect the aforesaid rights and causes of action more effectively in ASSIGNEE or to protect the same or

to enforce any claim or right of any kind with respect thereto. This includes, but is not limited to, any rights with respect to the TRADEMARK IN CLASS 025 ONLY that may have accrued in ASSIGNOR'S favor from the respective date of first use of the TRADEMARK IN CLASS 025 ONLY to the effective date of this Assignment. ASSIGNOR hereby declares that the foregoing power is coupled with an interest and as such is irrevocable.

ASSIGNOR hereby covenants that no assignment, sale, agreement, charge, or other encumbrance, has been, or will be, entered into which would conflict with this Assignment.

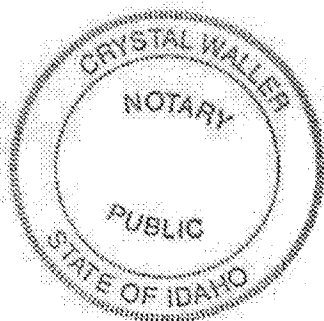
