2. Assignor will at any time upon request, without further or additional consideration, execute such additional writings, as Assignee or its successors and assigns may reasonably deem necessary or desirable in the enjoyment of this Trademark Assignment, and in enforcing any rights relating hereto.

3. The Commissioner for Trademarks of the United States is authorized and requested to recognize Assignee as the owner of the Marks, as applicable. Assignor also authorizes and requests the equivalent authorities in foreign countries to issue the Marks of foreign countries to Assignee as requested.

4. This Trademark Assignment and all the terms hereof will inure to the benefit of and be binding upon Assignor and Assignee and their respective successors, assigns and legal representatives.


