Marks and Domain Names Assignment Agreement

This mark assignment agreement (the "Agreement") is effective as of the date of its complete execution (the "Effective Date"), between Ride Plus, LLC, a Delaware limited liability company ("Ride Plus"), and LogistiCare Solutions, LLC, a Delaware limited liability company ("LogistiCare").

In consideration of valuable consideration paid to Ride Plus by LogistiCare, namely \$100, in addition to other valuable consideration from LogistiCare, the sufficiency of such consideration both parties acknowledge conclusively, the parties agree as follows:


1. Ride Plus covenants that it has adopted, used, and is the owner of certain service marks (the "Marks") and certain domain names (the "Domain Names"), each of which are listed on Schedule A attached hereto.

2. Ride Plus hereby assigns, transfers and conveys to LogistiCare all right, title and interest in and to the Marks and the Domain Names, including, without limitation, all goodwill of the business symbolized by the Marks, all common law rights in the Marks, and all Marks registration applications and registrations pertaining to the Marks.

3. Ride Plus shall take whatever action LogistiCare deems necessary or appropriate: (a) to properly complete the transfer to LogistiCare of the Marks and the Domain Names; (b) to establish full ownership of the Marks and the Domain Names by LogistiCare; and (3) to assist LogistiCare in obtaining, maintaining or strengthening any registration for the Marks.

4. This Agreement may be executed in counterparts. A true copy or facsimile of the undersigned signatures shall be treated as originals for all purposes. All counterparts when executed shall constitute one agreement binding upon all parties notwithstanding that all of the parties are not a signatory to the original or the same counterpart. A counterpart may be delivered to the other party by e-mail.




