TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (this "Agreement") is made by and between Harber Presents, LLC, a Texas limited liability company with a business mailing address at 7167 Waterlily Lane, Frisco, TX 75033 (the "Assignor"), and Untapped Festivals, LLC a Delaware limited liability company with a business mailing address at 508 Young Street, Dallas, TX 75202 (the "Company").

WITNESSETH:

WHEREAS, Assignor is the record owner of the federal application for the trademark UNTAPPED (Serial No. 85906932) for use in connection with "entertainment in the nature of live music festivals" (the "Mark"); and

WHEREAS, the Mark was, prior to the date hereof, acquired and assigned (the "Assignment") by Company from Assignor pursuant to separate agreements and instruments; and

WHEREAS, in consideration of the Assignment, in addition to consideration already given or paid, the Company agrees to prosecute the application for the Mark, maintain registrations for the Mark, and take over enforcing the Mark; and

WHEREAS, Assignor and the Company intend with this Agreement to evidence the Assignment and further intend that this Assignment be filed and made of record with the United States Patent and Trademark Office and any other appropriate location

NOW, THEREFORE, in consideration of these premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignor hereby assigns, transfers, and conveys unto the Company all of Assignor's worldwide right, title, and interest in and to the Mark, together with the associated goodwill; all income, royalties, and damages hereafter due or payable to the Company with respect to the Mark, including without limitation, the right to recover damages and profits for past infringement thereof.

2. The Assignor further agrees to execute all papers and to perform such other proper acts as may be necessary to secure for the Company or its designees the rights herein assigned, including but not limited to any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title, and interest in the Company, its successors, assigns and legal representatives.

3. This Agreement shall be governed by and construed in accordance with the laws of the United States of America and of the State of Texas.


4. This Agreement shall be deemed effective as of June 20, 2014 (the "Effective Date") the closing date of the Assignment.


