\* Explanatory information:

Piegorsch Associates Inc., formerly a corporation in South Carolina, was the original owner of the above-named Mark. I, Karen Piegorsch was the sole shareholder/owner and President of Piegorsch Associates Inc.. However, Piegorsch Associates Inc. no longer exists. In December 2006 I recorded Articles of Dissolution with South Carolina, for an effective date of closure on January 1, 2007.

On August 29, 2006, I incorporated and LLC in Arizona, Synergo LLC. I am the sole owner of Synergo LLC in Arizona.

In September 2006 I filed an Assignment with the USPTO, with the intention of transferring ownership of the above-named Mark from Piegorsch Associates, Inc. to Synergo LLC. However, I have recently learned that the type of Assignment I filed in 2006 was incorrect; I had filed a "Change of Name" but should have filed to "assign the entire interest and good will." For that reason, today I am filing a New Assignment with this form as supporting documentation.
