RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made as of July 13, 2015 (the "Effective Date"), by Rosenthal & Rosenthal, Inc., 1370 Broadway, New York, New York (the "Grantee").

2. The Grantee acknowledges and affirms that all of the rights, interests, and remedies of the Grantee concerning the CAMBIO Collateral pursuant to the Trademark Security Agreement and the Factoring Agreement are hereby terminated.

3. This Release shall not constitute a release of Grantee's security interest in any other trademark and/or collateral under the Factoring Agreement or Trademark Security Agreement, and the Factoring Agreement and Trademark Security Agreement shall each otherwise continue in full force and effect, including with respect to any such other trademarks and/or collateral.


