TRADEMARK AND DOMAIN NAME ASSIGNMENT AGREEMENT  
FIRST AMENDMENT

This First Amendment (the "Amendment"), dated May 18, 2015, (the "Effective Date") is between MM USA Holdings, Inc. (f/k/a MediMedia USA, Inc.) (the "Seller") and MMMM/CHC Holding, LLC, a Delaware limited liability company ("Assignee"). The Amendment amends that certain Trademark and Domain Name Assignment Agreement between the Seller and the Assignee dated February 27, 2015 (the "Assignment").

Pursuant to the Assignment, the Seller assigned to the Assignee certain trademarks and domain names owned by the Seller and related to the business of the Assignee. The parties intend to amend the Assignment by adding certain additional trademarks owned by the Seller to be assigned to the Assignee.


Accordingly, the parties agree as follows:

1. All capitalized terms used in this Amendment and not otherwise defined shall have the meanings set forth in the Agreement.
2. The Assignment is hereby amended as follows:
  - a. The first recital in the Assignment is deleted and replaced with the following:

"WHEREAS, the Seller owns rights in and the MEDIMEDIA, P&T and P&T FormKit.com marks (together with all associated logos used in connections therewith, the "Marks"), including the trademark registrations and applications for the Marks as set forth on Exhibit A attached hereto (collectively, the "Assigned Marks"), and is registrant of the domain name registrations set forth on Exhibit B attached hereto (the "Assigned Domain Names"); and"
  - b. Exhibit A of the Assignment is deleted in its entirety and replaced with Exhibit A of this Amendment.
3. Save as otherwise provided in this Amendment, all other terms of the Assignment remain in full force and effect.


