## TRADEMARK ASSIGNMENT

This Trademark Assignment (this "Trademark Assignment") is effective as of June 28, 2013, by and between Duet Health, LLC, an Ohio limited liability company ("Duet"), and Duet Health, Inc., a Delaware corporation, (the "Assignee"), with a corporate address of 1020 Dennison Avenue, Suite 202; Columbus, Ohio 43201.

### RECITALS

A. The Assignor is the owner of the DUET HEALTH Logo trademark registration (U.S. Reg. No. 4,312,017), together with the goodwill of the business associated therewith (the "Mark");

B. Pursuant to the terms of that certain Asset Purchase Agreement dated June 28, 2013, by and among the Assignor, the Assignee and certain other parties thereto (the "Purchase Agreement"), the Assignor agreed to transfer all of its right, title and interest in and to the Mark to the Assignee; and

C. This short form assignment is intended to memorialize the transfer of all of Assignor's right, title and interest in and to the Mark to the Assignee.

### AGREEMENTS

For the good and valuable consideration set forth in the Purchase Agreement, the receipt and sufficiency of which is hereby acknowledged, the Assignor and the Assignee hereby agree as follows:


1. The Assignor does hereby sell, assign, transfer, convey and deliver to the Assignee, *nunc pro tunc* as of June 28, 2013, its successors and permitted assigns, all of the Assignor's right, title and interest, in and to the Mark, and all of the goodwill of the business associated with the Mark, together with that portion of Assignor's business that is ongoing and existing to which the Mark pertains, and all registrations and pending applications for the Mark, any renewals of the registrations, in all countries throughout the world, for the Assignee's own use and enjoyment, and for the use and enjoyment of the Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignor if this Trademark Assignment had not been made.
2. This Trademark Assignment is in all respects subject to the provisions of the Purchase Agreement and is not intended in any way to supersede, limit, qualify or expand any provision of the Purchase Agreement.
3. This Trademark Assignment shall be binding upon, and shall inure to the benefit of, the parties hereto and their respective successors and assigns.


