## **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of July 1, 2015, is made by TD Bank, N.A., a national banking entity located at 2005 Market Street, One Commerce Square, 2<sup>nd</sup> Floor, Philadelphia, Pennsylvania 19312 (the "Secured Party") in favor of IOD Incorporated, a Wisconsin corporation located at 1030 Ontario Road, Green Bay Wisconsin 54311 (the "Grantor").

**WHEREAS**, pursuant to a Security Agreement (Trademarks), dated August 18, 2010, by and between the Grantor and the Secured Party (the "Trademark Security Agreement"), the Grantor granted a security interests in certain Collateral (as defined in the Trademark Security Agreement) to the Secured Party, including, without limitation, a security interest in those certain trademarks identified on Schedule A attached hereto (collectively, the "Trademarks");

**WHEREAS**, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on August 20, 2010, at Reel/Frame 4264/0699; and

**WHEREAS**, the Obligations have been fully paid and performed and the Secured Party has agreed to terminate and release its security interests in the Collateral, including all of the Trademarks.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release of Lien. The Secured Party hereby terminates, releases and cancels any and all mortgages, liens, and security interests granted to the Secured Party by the Grantor in and to the Collateral, including the Trademarks.

2. Further Assurances. The Secured Party agrees, upon written request of the Grantor, to execute and deliver to the Grantor, its successors, assigns or other legal representatives any and all further documents and instruments, and do any and all further acts which the Grantor (or its agents or designees) reasonably requests (at the Grantor's sole cost and expense) in order to effectuate the purpose of this Termination of Security Interest in Trademarks.

3. Authorization to Record. The Secured Party hereby authorizes the Grantor or the Grantor's authorized representative to record this Release with the United States Patent and Trademark Office and any applicable government officer record this Termination of Security Interest in Trademarks.

4. Governing Law. THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
