
NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor and Assignee hereby agree as set forth below:

1. Assignor does hereby assign, sell and transfer unto Assignee, its successors and assigns, all right, title and interest in and to the Mark, together with the goodwill of the business symbolized by the Mark, along with the right to recover from third parties damages and profits for past infringements thereof by such third parties, and Assignee does hereby accept such assignment, sale and transfer.
2. Assignor and Assignee each agree, at the request of the other party, at any time and from time to time following the date hereof to further execute and deliver to the requesting party such further instruments as may reasonably necessary or appropriate to more effectively confirm or carry out the provisions of this Assignment.
3. This Assignment may be executed by Assignor and Assignee in separate counterparts, each of which when so executed and delivered will be an original, but all such counterparts shall together constitute one and the same instrument. Each counterpart may be delivered by facsimile or email transmission, which transmission will be deemed delivery of an originally executed document.
