NOTICE OF RELEASE OF  
SECURITY INTEREST IN TRADEMARK

WHEREAS, pursuant to that certain Second Amended and Restated Trademark Security Agreement, dated as of November 23, 2009 (the "*Trademark Security Agreement*"), by each of the entities listed on the signature pages thereto (each a "*Grantor*" and, collectively, the "*Grantors*") in favor of Citicorp USA, Inc., as Collateral Agent (the "*Collateral Agent*"), recorded in the United States Patent and Trademark Office at Reel 4109, Frame 0651, each Grantor assigned and granted to the Collateral Agent a security interest in such Grantor's right, title and interest in and to the trademark listed on Exhibit A hereto (the "*Released Assets*"); and

WHEREAS, the Collateral Agent wishes to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its security interest in the Released Assets;

NOW THEREFORE, in consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby agree as follows:

1. Release. As of the date listed on the signature page hereto, the Collateral Agent hereby relinquishes, releases and discharges its security interest in the Released Assets.
2. Further Assurances. The Collateral Agent hereby agrees, at the Grantor's expense, to execute such instruments and to take such other actions as the Grantor may reasonably request to terminate the Collateral Agent's security interest in the Released Assets.
3. Governing Law. This Notice of Release of Security Interest in the Released Assets shall be governed by and construed and interpreted in accordance with the laws of the State of New York.
4. Definitions. Capitalized terms used herein and not defined shall have the respective meaning ascribed to such terms in the Trademark Security Agreement.


