**RELEASE OF A SECURITY INTEREST -- TRADEMARKS**

July 15, 2015

WHEREAS, pursuant to that certain Grant of Security Interest in United States Trademarks, dated as of March 10, 2015, recorded in the United States Patent and Trademark Office at Reel 5474, Frame 0935, SILICON IMAGE, INC., a Delaware corporation (together with its successors and assigns, the “Releasee”), *inter alias*, granted to JEFFERIES FINANCE LLC, as Administrative Agent for the ratable benefit of the Secured Creditors (“Releasor”), a continuing security interest in all right, title and interest of the Releasee in, to and under the United States Trademarks listed on the attached Schedule A (the “Trademarks”), together with, among other things, all Proceeds in respect thereof and the goodwill of the businesses associated with or symbolized by the Trademarks (with all of the Releasee’s rights listed above being collectively referred to as the “Collateral”) to secure the payment, performance and observance of the Obligations; and

WHEREAS, the Releasee has requested and Releasor has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Collateral.


NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Grant of Security Interest in United States Trademarks.
2. Release of Security Interest. Releasor hereby, without any representation and warranty and without any recourse to Releasor, releases, relinquishes and discharges all of its security interest in the Collateral.
