TRADEMARK ASSIGNMENT

Assignor does hereby irrevocably assign, grant and transfer to Assignee, all of Assignor's rights, title, and interest in and to the Trademark, including all common law rights, the Registration, and any and all other trademark registrations and applications for the Trademark, together with the goodwill of the business symbolized by the Trademark, and the right to sue third parties for and recover damages from past and future infringements of the Trademark, the same to be held and enjoyed by Assignee for its own use and enjoyment and the use and enjoyment of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment had not been made (the "Assignment").

Assignor hereby authorizes the United States Patent and Trademark Office, and any official of any other country empowered to issue trademark registrations, to record this Assignment, and to issue or transfer said Trademark and the Registration to Assignee as owner of all rights, title and interest therein, or otherwise as Assignee may direct, in accordance with the terms of the Assignment.
