ASSIGNMENT OF TRADEMARK

WHEREAS, Assignor has adopted and used in its business the trademark GOLDEN TIGER and DESIGN (the "Trademark"), which is the object of the United States Patent and Trademark Office Registration Number 3,953,206, Serial Number 77/879351, Registration Date May 3, 2011 (Registration); and

WHEREAS, Assignee, a New Hampshire corporation, desires to acquire any and all rights Assignor may have in and to the Trademark and the Registration therefor, together with the goodwill of the business symbolized by the Trademark and Registration therefor.

NOW, THEREFORE, the parties hereto agree as follows: Assignor hereby sells, assigns and sets over to Assignee for the sum of \$10.00 and other good and valuable consideration, the receipt of which is acknowledged, all of its rights, title and interests in and to the trademark GOLDEN TIGER and DESIGN, and the Registration therefor together with the goodwill of the business symbolized by the Trademark.

Assignor hereby agrees to cease and desist from using the Trademark as and from the present date and conforms that all proprietary interest and rights pertaining to the same and the Registration shall be property of the Assignee. Assignor agrees to execute and deliver, at the request of the Assignee, all papers, instruments, and assignments, and to perform all other reasonable acts Assignee may require in order to vest all Assignor's rights, title and interest in and to the Trademark and Registration in Assignee and to provide evidence to support any of the foregoing to the extent such evidence is in possession or control of Assignor. In addition, Assignee is granted the right to sue for infringement of the Trademark with respect to the Trademark anywhere in the world and is granted the right to recover damages for any past infringement of the Trademark and to recover and retain any monies paid if received as a result of such infringement.

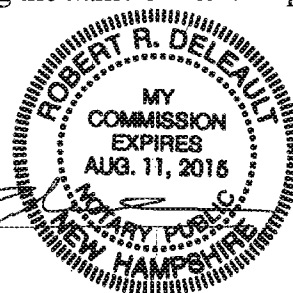
