RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this "Release") is made effective as of July 9, 2015, by GENERAL ELECTRIC CAPITAL CORPORATION, as administrative agent and collateral agent (the "Administrative Agent") to CARECENTRIX, INC., a Delaware corporation (the "Grantor") as follows:

WHEREAS, the Grantor and the Administrative Agent are parties to that certain Guaranty and Security Agreement dated as of September 19, 2011 (as may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") executed in order to secure the prompt and complete payment, observance and performance of all of the Secured Obligations in accordance with the terms and conditions of the various loan documents;

WHEREAS, pursuant to the Security Agreement, the Grantor was required to execute and deliver to the Administrative Agent a Trademark Security Agreement dated as of September 19, 2011 (the "Trademark Agreement");

WHEREAS, pursuant to the Security Agreement and Trademark Agreement, the Grantor granted to the Administrative Agent, among other collateral, a continuing security interest in all of Grantor's right, title and interest in, to and under the Trademark Collateral, as set forth in the Trademark Agreement, including the United States Trademarks listed on the attached Schedule A;

WHEREAS, the Trademark Agreement was recorded in the United States Patent & Trademark Office on September 19, 2011 at reel/frame 4625/0407; and


WHEREAS, the Administrative Agent wishes to release its security interest in the foregoing.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates, releases and discharges any security interest in and lien upon the Trademark Collateral, and assigns, transfers, and conveys to the Grantor any and all right, title or interest in, or to, the Trademark Collateral that the Administrative Agent may hold.
