TRADEMARK AND INTELLECTUAL PROPERTY ASSIGNMENT

This Trademark and Intellectual Property Assignment Agreement (“Agreement”) is made effective as of this 14th day of July, 2015, (the “Effective Date”) from Dart Warz, LLC, an Idaho limited liability company, now known as Dart Warz Meridian, LLC, by Amendment to Certificate of Organization - Limited Liability Company, filed with the Idaho Secretary of State on May 7, 2014 and attached hereto as Exhibit A (“ASSIGNOR”), to Dart Warz Holdings, LLC, an Idaho limited liability company with an address at 501 E. Scenery Lane, Suite 190, Meridian, Idaho 83642 (“ASSIGNEE”).

WHEREAS, ASSIGNOR is the owner of the trademarks described in Exhibit B (collectively, the “MARKS”), attached hereto and incorporated by reference herein, together with the goodwill of the business symbolized thereby; and

WHEREAS, ASSIGNOR desires to convey, transfer, assign, deliver, and contribute to ASSIGNEE all of its right, title, and interest in and to the MARKS and the goodwill represented thereby; and

WHEREAS, ASSIGNOR, Stanton Wilkerson and Randi Wilkerson are the owners of other intellectual property described in Exhibit C (collectively, the “OTHER IP”), attached hereto and incorporated by reference herein

NOW, THEREFORE, in consideration of one dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE, and ASSIGNEE hereby accepts, all of ASSIGNOR’S right, title, and interest of whatever kind in and to the MARKS together with (1) the goodwill of the business symbolized thereby; (2) all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the MARKS, including without limitation, damages and payments for past or future infringements and misappropriations of the MARKS; (3) all rights to sue for past, present, and future infringements or misappropriations of the MARKS; and (4) the right to apply for and prosecute trademark registrations within or outside the United States based in whole or in part upon the MARKS, and any priority right that may arise from the MARKS.

ASSIGNOR further covenants that it will execute all documents, papers, forms, and authorizations and take all other actions that may be necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the MARKS.

NOW, THEREFORE, in consideration of one dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR, Stanton Wilkerson and Randi Wilkerson hereby convey, transfer, assign, deliver, and contribute to ASSIGNEE, and ASSIGNEE hereby accepts, all of ASSIGNOR’S, Stanton Wilkerson’s and Randi Wilkerson’s right, title, and interest of whatever kind in and to the OTHER IP together with (1) all income, royalties, and damages hereafter due or payable to ASSIGNOR, Stanton Wilkerson or Randi Wilkerson with respect to the OTHER IP, including without limitation, damages and payments for past or future infringements and misappropriations

of the OTHER IP; (2) all rights to sue for past, present, and future infringements or misappropriations of the OTHER IP; and (3) the right to apply for and prosecute patent applications and other registrations within or outside the United States based in whole or in part upon the OTHER IP, and any priority right that may arise from the OTHER IP.

This Trademark and Intellectual Property Assignment Agreement may be executed by the parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all such counterparts taken together shall constitute one and the same instrument. Each counterpart may be delivered by facsimile transmission, which transmission shall be deemed delivery of an originally executed document. In any dispute arising out of this Agreement, the parties hereby consents to the jurisdiction of and exclusive venue within the state or federal courts located in the state of Idaho.




