## ASSIGNMENT OF INTELLECTUAL PROPERTY

This ASSIGNMENT OF INTELLECTUAL PROPERTY (this "Assignment") is made this 19<sup>th</sup> day of June, 2015, in favor of LDiscovery, LLC, a Delaware limited liability company ("Buyer"), by InterLegis, Inc., a Texas corporation ("Seller").

### RECITALS

WHEREAS, this Assignment is made pursuant to that certain Asset Purchase Agreement (the "Purchase Agreement"), dated as of June 19, 2015, by and between Seller and Buyer; and

WHEREAS, capitalized terms used but not defined herein shall have the meanings set forth in the Purchase Agreement; and

WHEREAS, pursuant to the Purchase Agreement, Seller has agreed to sell, convey, transfer, assign and deliver to Buyer, free and clear of all Encumbrances, all Purchased Intellectual Property and Licensed Intellectual Property (collectively, "Company Intellectual Property"), and Buyer has agreed to accept such assignment.

NOW, THEREFORE, pursuant to the terms and conditions of the Purchase Agreement and in consideration of the mutual covenants and agreements contained therein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Assignment. Seller hereby sells, conveys, transfers, assigns and delivers to Buyer, free and clear of all Encumbrances, all Company Intellectual Property, including the Intellectual Property listed on Exhibit A, including all rights therein whether statutory or at common law, including all registrations and applications therefor, the right to sue and recover for all past, present and future infringements and other violations of the Company Intellectual Property, and the goodwill associated with such Company Intellectual Property in the operation of the Business, the same to be held and enjoyed by Buyer to the same extent that such would have been held and enjoyed by Seller had this assignment not been made, and Buyer hereby accepts the assignment.

2. Purchase Agreement. This Assignment is intended to evidence the consummation of the transactions contemplated by the Purchase Agreement and is subject to the terms and conditions set forth in the Purchase Agreement. Nothing contained in this Assignment shall be construed to supersede, limit or qualify any provision of the Purchase Agreement. To the extent there is a conflict between the terms and provisions of this Assignment and the terms and provisions of the Purchase Agreement, the terms and provisions of the Purchase Agreement shall govern.

3. Further Assurances. Seller agrees to use its commercially reasonable efforts to take or cause to be taken such further action, to execute, deliver and file or cause to be executed, delivered and filed such further documents and instruments, and to obtain such consents, as may be necessary or as may be reasonably requested in order to effectuate fully the purposes, terms and conditions of the Purchase Agreement.

4. Controlling Law. This Assignment will be governed by and construed and enforced in accordance with the internal laws of the State of Delaware without reference to its choice of law rules.

5. Successors and Assigns. This Assignment will be binding upon and will inure to the benefit of the Parties and their successors and permitted assigns, and any reference to a Party will also be a reference to a successor or permitted assign. Any assignment or transfer in violation of this Section 5 shall be void and of no force and effect.
