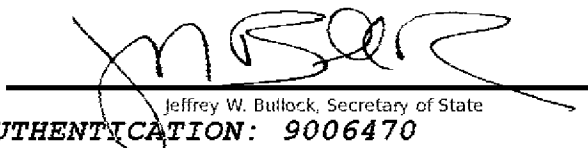

**CERTIFICATE OF MERGER  
OF

Pursuant to Title 8, Section 252(c) of the Delaware General Corporation Law, the undersigned corporation executed the following Certificate of Merger:

**FIRST:** The names of the constituent corporations in the merger are Global Market Insite Delaware, Inc. a Delaware corporation ("GMI DE"), which is the surviving corporation, and Global Market Insite, Inc., a Washington corporation ("GMI WA").

**SECOND:** The Agreement and Plan of Reorganization, dated as of July 26, 2011 (the "Agreement and Plan of Reorganization"), by and among KMR Holdings Inc., KMR Acquisition Corporation, GMI DE, GMI WA and Financial Technology Ventures II (Q), L.P., has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations in accordance with Title 8, Section 252 of the Delaware General Corporation Law.

**THIRD:** The name of the surviving corporation is Global Market Insite, Inc., a Delaware corporation (the "Surviving Corporation").

**FOURTH:** The Certificate of Incorporation of GMI DE shall be the Certificate of Incorporation of the Surviving Corporation, except that Article I of the Certificate of Incorporation of GMI DE shall be amended to change the name of the Surviving Corporation to "Global Market Insite, Inc."

**FIFTH:** The merger is to become effective upon the filing of this Certificate of Merger with the Secretary of State of the State of Delaware.

**SIXTH:** The executed Agreement and Plan of Reorganization is on file at 1100-112<sup>th</sup> Ave. NE, Suite 200, Bellevue, Washington 98004, the place of business of the Surviving Corporation.

**SEVENTH:** A copy of the Agreement and Plan of Reorganization will be furnished by the Surviving Corporation on request, without cost, to any stockholder of the constituent corporations.

**EIGHTH:** The authorized stock and par value of GMI WA is 54,905,500 shares of Common Stock, par value \$0.001 per share, and 25,186,926 shares of Preferred Stock, of which 2,278,240 shares are designated Series A Preferred Stock, par value \$0.001 per share, 771,500 shares are designated Series A1 Preferred Stock, par value \$0.001 per share, 7,004,128 shares are designated Series B Preferred Stock, par value \$0.001 per

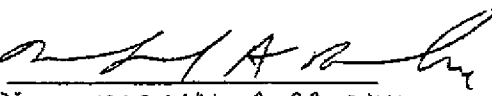
share, 3,502,060 shares are designated B-1 Preferred Stock, par value \$0.001 per share, 11,630,998 shares are designated Series C Preferred Stock, par value \$0.001 per share, and 3,250,000 shares are designated Series D Preferred Stock, par value \$0.001 per share.
