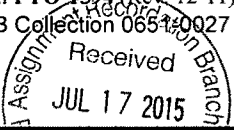

CERVALIS LLC, a Delaware limited liability company (the "Assignor"), entered into a certain Trademark Security Agreement, recorded in the United States Patent and Trademark Office on February 8, 2013, at Reel 4958, Frame 0828 (the "Security Interest"), whereby Assignor granted WILMINGTON TRUST COMPANY (the "Assignee"), as Agent pursuant to that certain Second Lien Credit Agreement dated as of February 8, 2013 by and among Assignor, Cervalis Holdings LLC, the Assignee and the lenders parties thereto (the "Lenders"), a security interest in the trademark and the federal application therefor and resulting registration thereof identified on Schedule A hereto and incorporated herein by reference, including the goodwill associated therewith (the "Mark").


